Thank you for considering nominating your riding age horse to our first Spring Sale! Please read through the nomination package and if you have any questions please don't hesitate to reach out to one of our admin team. We are here to assist you in selling your quality riding horse for a good price. We will do our best to help you market your horse and bring more bidders to you. In order to do this, we need your help by providing us with as much high-quality marketing material that you have available, including show video, professional show photos and well written catalogue notes on your horse's accomplishments. On the Presentation days you will need to present a well prepared, professionally turned-out horse. We cannot market what we do not have on video or photos!

### **How to Proceed**

- ✓ Nomination Deadline is March 15th, 2021.
- Complete the Nomination form on-line and click the submit button
  - Scan the horse's registration certificate or proof of pending registration
  - Scan the EC/USEF/FEI passport for Performance horses and School Masters (we are looking for the page with the passport #)
- Admin fee due when nomination form completed and submitted. Etransfer etransfer @cwauction.ca ..... \$150
- ✓ Once your horse has been accepted into the sale you will be notified by email no later than March 22<sup>nd</sup>. You will then be required to do the following:
  - Balance of Nomination Fee payable (see email acceptance email for amount).
  - Catalogue notes submitted **NO LATER THAN April 1**st for the nominated horse, its sire and dam. The more detail the better on your horses' successes
  - Conformation photo of the horse standing in the open stance taken from the side and or photo of the horse at a competition.
  - Video of the horse competing is very helpful in selling a performance or school master for a good price. Please provide **NO LATER THAN April 1st.** These will be included on your horses' auction page.
  - All nominated horses will be required to attend one of our 2 presentation days.
    - Presentation days will be March 28<sup>th</sup> and 29<sup>th</sup> Location TBD
    - o A representative will contact you via phone / email as to schedule which day will best suit you.
    - o At these events your horse will get professional Video done and photos taken performing either over fences or on the flat. They will also have professional conformation and head shots taken that will be used for marketing and sale purposes. This marketing material will be provided to each consignor to use for their own personal use as well.
- ✓ Consignor must be a current member in good standing with CWHBA. Please contact us for a fillable form and we will be happy to assist in getting your membership up to date.
- ✓ Sold horses will be insured for 10 days following the close of the sale
- ✓ The seller is obligated to provide board at no charge for up to 10 days following the close of the sale.

### **Terms, Conditions, Limiting Criteria & Governing Policy**

#### **BASIC ELIGIBILITY**

Horses eligible for nomination must be registered Canadian Warmblood or with another recognized Warmblood registry (as in 1 and 2 below):

### **LIMITING CRITERIA**

- Priority will be given to Canadian-born horses with a limited number of imports being permitted at the discretion of the sale committee
- Special consideration MAY be giving to horses with an exceptional show record that the sale committee feels will be an asset to the Spring Riding Horse Sale
- 25 lots will be accepted for the sale
- Other Limiting criteria will be based off of Performance and / or Pedigree. In your nomination, please include as much information as possible about your horse's performance record, schooling shows, ability (free jump video for a jumper prospect or free movement for dressage prospects), other noteworthy siblings out of the dam-line and any other pertinent information for the selection committee to make their decision.

Prospects	Prospects – 5 or older – must be started under saddle
* Must be 3 to 6	3 or 4 years old – started under saddle <u>or</u> ready to start under saddle.
years of age	Preference MAY be giving to horses that are started.
Performance Horses	Performance horses must have shown at a minimum of two EC or USEF rated
* Must be 5 to 12	shows or have proof of attending five schooling shows in the past 18 months.
years of age	Preference MAY be giving to horse with an outstanding show record.
School Masters	School Masters must have shown on average at a minimum of two EC or USEF
Must be 8 to 15	rated shows per year for the past 4 years with results in the Jr/Am division OR be
years of age	an upper-level horse who is ready to step down out of the Professional division
	and take care of a Jr/Am. These horses are meant to be horses who can tolerate
	and teach a rider the ropes. These horses will be selected and accepted at the
	discretion of the sale committee – please provide video of the horse at the time of
	nomination that reflects the horse's suitability to be a school master.

### **Nominations**

- All owners agree that by nominating their horse(s) they will provide the sale with all required veterinarian
  documentation including: x-rays, EIA, insurance forms, vaccination record, medication form and videoed
  flexion tests that will be sent to the admin team by the dates specified in the 'Important Dates and
  Deadlines' section below. Failure to do so will forfeit all fees and your horse will not be sold through the
  sale!
- All owners agree that by nominating their horse(s) they will allow them to be tested for any banned substances according to the Equine Canada Medication Control Committee. Every horse will have blood drawn at their PPE and it will be held for 45 days after the sale.
- Where the owner of a horse is a partnership, limited company, ranch or farm all legal signatories must sign the nomination form.
- All information and representations of the horses consigned are the sole responsibility of the seller or agent of the seller.
- The seller acknowledges that each horse consigned is free and clear of all liens, warrants and encumbrances.
- All horses sold <u>must</u> have their transfer of ownership completed and sent to their respective registries
  within 10 days of the sale. Proof that the transfer has been completed and that it has been sent must be
  forward to the sale administrator so that your payment can be released. The Sales Admin can assist you
  with all documentation. In the case of a pending registration, the transfer must be completed and sent to
  the registrar to finalize once the registration certificate is done.

#### **COMMISSIONS**

A commission will be charged on each horse sold at the following rates:

10%	On the first \$20,000	
7.5%	From \$20,001 to \$30,000	
5%	5% From \$30,001 to \$50,000	
6% flat fee	On any horse sold for more than \$50,001	

No selling commission will be charged for horses who are not sold. The last bidder must be the owner OR agent OR representative for this to be valid. The sale admin must be notified immediately after the close of the sale if the bidder represents the owner

### **MINIMUM BIDS**

Minimum starting bid will be set at \$6,000 for all categories

#### **FINAL DISBURSEMENTS**

- 1. CWHBA Alberta Chapter acts only as a clearing house for funds collected for and on behalf of the seller
- 2. GST is collected for and on behalf of the seller ONLY when the seller provides a valid GST registration #
- 3. Consignor's accounts will be settled when the bank hold has been released from the purchaser's funds
- 4. Cheques will be sent via Xpress post and the release of the funds will be dependant on where the funds originated from – i.e. expect:
  - a) 7 days within province b) 10 days out of province c) 21 days out of country
- 5. Each consignor will be issued a single cheque to settle the account
- 6. For multiple consignments, settlement will occur when final purchaser funds are released

March 25 <sup>th</sup>	Payment Due for the remainder of the nomination fee(s) for each of your selected horse(s) – Refer to acceptance email for balance owing – this payment is required in order to attend the presentation day	
March 28 <u>or</u> 29 <sup>th</sup>	Presentation Days – Horses required to come to pre-determined location for one day  • A member of the admin team will contact you via phone and email to confirm which date works best for your horses needs and your schedule	
April 1 <sup>st</sup>	Send the link of your X-rays to <a href="mailto:admin@cwauction.ca">admin@cwauction.ca</a> X-ray deadlines → these can be taken anytime after January 25 <sup>th</sup> but the link sent from your vet must be forwarded no sooner than April 1 <sup>st</sup> as there is only a 30-day timeframe for viewing. We don't want any issues by potential buyers on the sale weekend. Please see your consignors' package for required x-ray views — these were included with your March 22 <sup>nd</sup> email

April 8 <sup>th</sup> to 26 <sup>th</sup>	Tryouts can be booked for your horse with any potential bidders at your own discretion

If your horse does NOT have a current (Jan 1 <sup>st</sup> or newer) coggins test (EIA), please have one done at this exam
